

Tenders with valid EMD only shall be considered for opening of Tender.

Tenderers who have executed successfully similar nature of works i.e. providing support services/any other support services of required magnitude and who satisfy the eligibility criteria as given below will be considered for issue of tender document.

Intending tenderers may submit application for the work for issue of tender along with attested copies of proof of

(a) Registration in appropriate class in Government Organizations, Undertakings & Enterprises is desirable.

(b) List of works of similar nature and magnitude in hand and those already carried out by them for the last five years ending 2019.

(c) Performance/completion certificates issued by respective departmental engineers for the following for the last 7 years ending on 2019

One similar work completed costing not less than 80% of Estimated cost put to tender or two similar works completed costing not less than 60% of Estimated cost put to tender or three similar works completed costing not less than 40% of Estimated cost put to tender

(d) Bank Solvency Certificate shall be not less than 40% of Estimated cost and issued not older than 1 year from the date of opening of Tender.

(e) List of Plants & Machineries.

(f) List of technical Staff they possess

(g) Copy of PAN/TAN Card issued by the Income Tax Department

(h) Average Annual turnover of company for the last three years shall be not less than 100% of the estimated cost during immediate last 3 consecutive financial years.

(i) Any other supporting documents / credentials deemed useful.


