As regards Sr. No. 37 and 38, the Committee observed that since the applications have been submitted after a long gap of death of the Government servant, the cases could not be considered. The Scheme of Compassionate Appointment states that the concept of compassionate appointment is largely related to the need for immediate assistance to the family of the Government servant in order to relieve it from economic distress. The very fact that the family has been able to manage somehow all these years should normally be taken as adequate proof that the family had some dependable means of subsistence*.

With regard to SI.No. 39, the Committee observed that Shri Himank Kumar another brother of late Shri Vedant Kumar Tiwari is gainfully employed in Department of Police, Uttar Pradesh. Moreover, family pension has not extended to any of the family member of Shri Vedant Kumar Tiwari since there are no eligible family members. Hence the case could not be considered

As regards to SI.No. 40, the Committee observed that Ms. Vaishnavi D/o late Smt. Asoori Latha, Ex- Scientific Officer/ F has not submitted the revised application. However, based on the available data, the relative points for Ms. Vaishnavi have been calculated and with relative points of 33 it is evident that Ms. Vaishnavi is not likely to get recommended for employment due to less deserving circumstances. Hence the case could not be considered.
